programme overview

The Department of Economics of the University of Cyprus is offering a Master's program in Economic Analysis, a competitive degree aiming to strengthen your **econometric skills**, enhance your **theoretical and practical competencies in economic analysis**, and gain experience in **applying quantitative and qualitative methods**.

This program consists of rigorous graduate level courses in economic theory and econometric methods, aiming to equip students with tools useful in the modern economy and to prepare them for research at the Ph.D. level at the University of Cyprus or other institutions. Graduates have been successful at entering top 20 US Economics PhD programs.

The total **tuition fee** is 5125 euro for all students. It is offered in the **English** language and can be completed in **twelve months**. All applicants will be eligible for fellowships offered by the Department of Economics. Additional fellowships will be offered by the University of Cyprus to select students. Teaching and Research assistantships at the Department are also available for most successful candidates.

Complete applications should be sent to the address below, with official transcripts, a CV, two letters of recommendation, and official results for the TOEFL (minimum score is 550, or 213 in the computer based format exam, TOEFL Code number 4189), or GCE O-level (minimum letter grade is B) or an equivalent qualification demonstrating sufficient knowledge of the English language. GRE official results are desirable.
