

DECLARATION OF A PhD STUDENT

FOR THE ACCEPTANCE OF A FULL SCHOLARSHIP

I PhD student in the Department of of the University of Cyprus, with student ID number I hereby declare that I accept this Full Scholarship awarded to me for up to three (3) academic years as from the fall/spring semester of the academic year

I also hereby declare that I am not working within or outside the University of Cyprus during the tenure of this Scholarship as a Postgraduate Research Associate, Special Teaching Staff, University Research Associate, Teaching Assistant, Administrative staff or in any other position for more than 40 hours per month, and that I do not receive any other scholarship or income either from the University of Cyprus or from any other institution/organization, etc. If during the tenure of this scholarship one of the above occurs, I must immediately notify in writing the Graduate School of the University of Cyprus. The scholarship will cease immediately, unless the Graduate School decides otherwise. I will also arrange to secure the approval of the Dean of Graduate School upon the recommendation of the Chair of the department, in case during the scholarship I will work in any position inside or outside the University of Cyprus with an employment of less than 40 hours per month.

I understand that:

- (a) if during my studies or after the completion of my studies, comes to the knowledge of the University of Cyprus, that there was a reason why I was not eligible for the award of this scholarship and I failed to notify this to the Graduate School, then I might be required to reimburse the University the total amount of the scholarship including interest. In addition, the Graduate School has the absolute right to exclude me from participating in any future scholarship procedures which are either funded from the Graduate School or from the University of Cyprus in general.
- (b) if I withdraw from the study program and the University of Cyprus before I complete the requirements of the program and obtain the PhD degree, the scholarship will terminate and, in this case, the University of Cyprus reserves the right to claim the reimbursement of the amount paid corresponding to the tuition fees.
- (c) if I am employed full-time, inside or outside the University of Cyprus, the scholarship will terminate and, in this case, I should return to the University of Cyprus the proportion of the amount of the living allowance I have received based on the date of my employment.

(d) if at the same time I receive another scholarship from the University of Cyprus or from another institution/organization/foundation etc., the *Evagoras* scholarship will terminate and, in this case, the University of Cyprus reserves the right to claim the reimbursement of the amount paid corresponding to tuition fees and living allowance with the exception of the scholarship supplement that my academic department might have awarded me from its own revenue, with the approval of the Dean of the Graduate School.

At the end of each academic year, I undertake to submit to the Graduate School, a Progress Report on my research.

I am aware that during the period of the Scholarship I will be assigned Teaching Assistant duties or other duties at the academic department, the equivalent of four hours of work per week during the term of the scholarship without receiving any additional payment.
