The European Green Deal requires an ambitious decarbonisation effort of all the polluting sectors of the economy, in order for the European Union to reach the target of climate neutrality by the year 2050. The energy sector is far from being an exception: it faces existential questions since it is subject to the decarbonisation strategy while at the same time aiming to reconcile the numerous objectives of the Energy Union project: reduce energy dependency by maintaining the security of supply and increasing the energy efficiency, achieve a fully intergrated energy market, invest in research and innovation.

The development of trans-European energy infrastructure constitutes a core element of the european energy policy according to article 194 TFEU. Such development must, however, be aligned to the climate strategy of the EU. This is the reason why the main legislative instrument in this area, viz. the Regulation on guidelines for trans-European energy infrastructure (TEN-E Regulation), needs to be revised: the sustainability goal deserves a more prominent role. The legislative proposal for its revision has been published in December 2020 – aka. prior to the "Fit for 55" proposals - and (together with the Taxonomy dossier) it has set the tone for the negotiations and shed light on the diverging approaches of the Member states, regions and economic actors when it comes to decarbonisation strategies, means and pace.

This seminar will focus on the revision of the TEN-E Regulation discussing the gas industry related topics that arose and were heavily debated during the different phases of the interinstitutional negotiations.
