**The University of Cyprus (Operation of the Graduate School) Regulations of 2011 and 2021, as published in the Official Gazette of the Republic of Cyprus on 8 April 2007 and 4 March 2021.**

The Council of the University of Cyprus, in the exercise of the powers vested in it by Article 32 of the University of Cyprus Laws 1989 to 2019, hereby makes, with the approval of the Council of Ministers, the following Regulations:

- 1.** These Regulations may be cited as the University of Cyprus (Operation of the Graduate School) Regulations of 2011 and 2021.

- Interpretation. **2.** (1) For the purposes of these Regulations, unless the context otherwise requires----
- “Law” means the University of Cyprus Law of 1989 to 2007.
- “School” means the Graduate School established under the University of Cyprus (Establishment of Faculties and Departments by Faculty) (Amendment) Regulations of 2011.

- (2) Any other terms shall have the meaning assigned to them by the Law.
- Administration of the School. **3.** The School shall be administered by the Board of the School.
- Composition of the Board of the School. **4.** The composition of the Board of the School shall be as follows:
- (a) the Dean of the School, as Chairperson;
- (b) the Deputy Dean of the School;
- (c) one member of the Postgraduate Studies Committee of each Department, appointed by the Board of each Department. The member’s selection shall be ratified by the Senate;

- (c1) In the case of the Medical School, one member from each Sector of the Medical School shall participate. Each such member shall be appointed by the Board of Sectors of the Medical School, and his/her selection shall be ratified by the Senate:
- Provided that, until the Medical School becomes autonomous, one member of the Board of Sectors of the Medical School, appointed by that Board and whose selection shall be ratified by a decision of the Senate, shall participate in the Board of the Graduate School;
- (d) representatives of postgraduate students, in a number equal to the nearest integer corresponding to 1/3 of the total number of members of the academic staff of the Board of the School:
- Provided that, in the event that the Board of the School comprises more than thirty (30) academic staff members, students shall be represented with ten (10) members.
- Election of Dean and Deputy Dean. **5.** (1) The Dean and the Deputy Dean of the Graduate School shall be elected by the members of the Boards of the other existing Faculties of the University.
- (2) All Professors of the University of Cyprus may be candidates for the office of the Dean of the School, while all Professors and Associate

Professors of the University of Cyprus may be candidates for the office of the Deputy Dean of the School.

- (3) The Dean and the Deputy Dean of the School shall be from different Faculties.

Procedure for the announcement and election of the Dean and the Deputy Dean.

- 6.** The procedure for the announcement and election of the Dean and the Deputy Dean, as well as their duties and responsibilities, shall be provided for in Rules approved by the Senate and ratified by the Council.

Incompatibility of the offices of Dean and Deputy Dean.

- 7.** The offices of the Dean and the Deputy Dean of the School shall be incompatible with the office of the Rector, the Vice-Rector, the Dean and the Deputy Dean of another Faculty, as well as with the office of the Chairperson and the Vice-Chairperson of the Department.

Term of office of the Dean and the Deputy Dean.

- 8.** The term of office of the Dean and the Deputy Dean of the School shall be three years, with the possibility of one re-election.

Rules of Operation of the School.

- 9.** Matters relating to the operation of the School, and in particular to the admission of students, the award of degrees, and the evaluation of the School, shall be governed by Rules approved by the Senate and ratified by the Council:

Provided that, the following Regulations, as amended from time to time, shall apply in relation to the School in the same manner as they apply to the other Faculties of the University:
